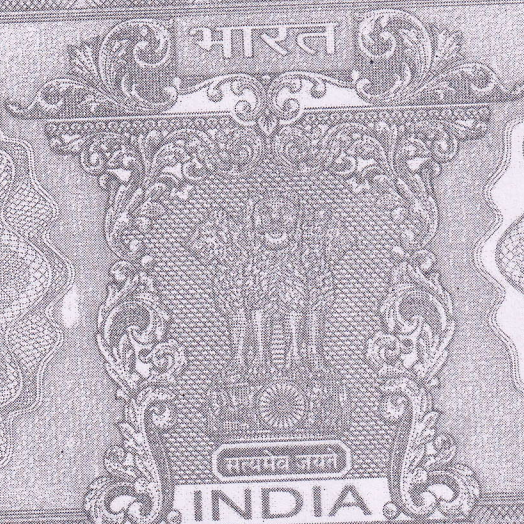

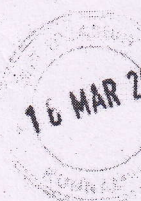
1. THE ALFALAH CHARITABLE TRUST is a registered Trust under the INDIAN TRUST ACT 1882.
